Director and Librarian Reports:

• Ashcroft's Rule:

A committee of public librarians are working on a policy that will follow Ashcroft's rule. Lawyers have suggested that every section of library should be labeled for age appropriateness (0-11, 12-18, 18 and over). Can't use state aid money for questionable material. Presentations must also have age range designations. Anyone challenging what is being done must live in the district and also have a child living there. All policies must be submitted to Secretary of State's office by July 31st.

- Furnace will be replaced in Iberia tomorrow, May 17, 2023.
- People around the United States sent letters to Missouri in our support.
- MPLD June Conference will be May 31st-June 2nd, 2023.
- Copier overages: It is more economical to pay overages than to go to the higher amount.

- Beanstack and Goosechase subscriptions were cancelled because of lack of use.
- Lisa is on the committee to evaluate Mark Twain books. Kacie is on The Missouri Association of School Librarians Truman Committee to evaluate books.
- Other librarians gave reports on what they are doing: Summer Programs; Kindness Rocks; Sharing is Caring; Happy Trails; Book Clubs; Read, Learn, Experience; Read, Chat, Create; Crafternoon; Author Talk; Chair Yoga; etc.
